EACH PLAYER MUST READ THE FOLLOWING WAIVER AND RELEASE ALL CLAIMS BEFORE SIGNING THE ROSTER ON THE REVERSE SIDE.

In consideration for the privilege to participate in the Saguaro Cup Sports Festival, hereinafter referred to as SCSF, and its associated events, I for myself, my heirs, executors, administrators, and assigns do hereby release, waive, and/or forever discharge any and all rights and claims that may be suffered by me as a result of my preparation for and/or participation in SCSF contests and related activities.

I recognize and voluntarily accept all risk and hazards associated with my participation in the SCSF, no matter how remote or unlikely, including the possibility of serious bodily injury, catastrophic spinal injury, total or partial paralysis, disfigurement permanent impairment, and event death. I realize that the cause of such injuries include, but are not limited to, running, falling, tripping, or being pushed, as well as by means of striking or being struck by another participant, a spectator, game equipment or a vehicle.

As an adult, I take full responsibility for my participation in the SCSF and for the level at which I choose to be involved. I understand and accept that I am solely responsible for limiting my level of participation, if necessary with respect to any physical or mental impairment I may have. I affirm that I have the requisite skills, training, experience, and abilities and am physically fit to the extent necessary for my level of participation. I also understand that I can choose to remove myself from participating in the SCSF or its events at any time.

I do not expect the SCSF, its agents, volunteers, or officers to coach, manage, instruct, or train me for the activities. I also recognize that it is my personal responsibility to learn, understand, and obey the rules of softball and the SCSF.

I agree to abide by the SCSF Sports Code of Conduct at all times when attending any SCSF sanctioned event. I acknowledge that league directors and umpires reserve the right to punish any perceived infringement of unsportsmanlike conduct or violation of the SCSF Sports Code of Conduct, which could result in punishment including but not limited to removal from all SCSF events.

I am fully aware and agree that I cannot, in whole or in part, rescind, revoke, or otherwise withdraw the foregoing Waiver and Release of All Claims. I also realize that it will not expire and that no activity by me shall cause it to be terminated, extinguished or canceled in any way.

I thoroughly understand that the foregoing Waiver and Release of All Claims is intended to be as broad and inclusive as is permitted by the laws of the State of Arizona and that if any segment or section thereof is ruled to be invalid, notwithstanding that portion, I expressly agree that the balance shall continue in full legal force and effect.

I have carefully read the hold-harmless Waiver and Release of All Claims and fully understand its contents, meaning, and effect as a complete waiver and release of all claims, liability, and indemnity for the Cactus Cities Softball League, the Saguaro Cup Sports Festival, its agents, volunteers, and officers.
